#### BYLAW 2017-06

# A BYLAW OF THE VILLAGE OF CLAVET TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF THE SEWER SYSTEM.

The Council of the Village of Clavet in the Province of Saskatchewan, enacts as follows:

- For the purpose of this Bylaw, the expression:
   (a) "Municipality" shall mean the Village of Clavet
- 2. All person(s) desiring to be supplied with water from the Municipality's Water supply system shall make application to the officials of the Municipality.
- 3. The Municipality may, by Resolution, ration or limit the amount of Water furnished to any and/or all consumers should circumstances deem to warrant such action.
- 4. All Water consumers shall pay a deposit for every water meter installed for any water connection to the water system of the Village, the said deposit as required, is set out in **Schedule "D"** of this Bylaw as a condition of the Village supplying Water to the said consumer. The said deposit shall be refunded to the consumer when service to such consumer is discontinued and/or the meter is removed.
- 5. Where a Water meter is damaged due to a consumer's act or omission, the cost of repair or replacement of the meter shall be borne by the consumer.
- A consumer may, on request, have a Water meter checked for accuracy.(a) Council may from time to time fix, by resolution, the fee to be charged for the various types of service connections.
- 7. No Water rates shall be payable after disconnection, if a Water connection has been turned off at the street by the servants of the Village at the request of the consumer.
- 8. The minimum Water & Sewer charges per month are set out in Schedule "A" and "B" of this Bylaw and shall apply where a consumer has notified the Village that no water will be used but has not requested discontinuance of service or the removal of the meter.

- 9. All Water and Sewer accounts shall be rendered **Six** (6) times per year and will cover a **Two** (2) month period. Billings shall be rendered the first day of the billing month and no later than the 10<sup>th</sup> day of that month.
- 10. Water meters shall be read **Six** (6) times per year by Village Staff or Property Owners.
- 11. All Water and Sewer accounts are due and payable when rendered.

  If Water and Sewer rates and charges are unpaid after **Sixty** (60) days from the date of mailing the account, service may be discontinued without notice.
- 12. If the Water supply is shut off from the premises of a user for infringement of the provisions of this Bylaw, same shall not be turned on until all penalties, fees, rates, charges and arrears, if any, have been paid in full or arrangements have been made with the Village Office to make payments.

A fee of \$50.00 will be charged to cover the expenses of turning off /on the Water during regular office hours

If Water is turned off/on outside of employees' regular working hours, the fee shall be \$100.00.

- 13. All rates, costs or charges imposed by this Bylaw in arrears and unpaid at December 31, will be transferred to the Tax roll of the Village and will levied and collected in like manner as Municipal rates and Taxes are by law recoverable.
- 14. The charges to be paid by the consumer for Water and Sewer service are set out in Schedule "A" and "B" as attached to this Bylaw, or as amended from time to time.
- 15. Subject to Section 30 of *The Municipalities Act*, any person who causes any loss, damage or injury to any public utility service or any land, buildings or personal property used in providing the public utility service, whether owned by the urban municipality or not, is liable to the owner for that loss, damage or injury.

- 18. Bylaw #2011-01; # 2012-01 and #2015-05 are hereby repealed.
- 19. Persons connected to the Water and Sewer System in the Village shall pay the Monthly Infrastructure Fees as set out in **Schedule "C"** as attached.
- 20. The rates, charges, tolls or rents contained in this Bylaw shall come into force and take effect on the date of approval being issued by the Local Government Committee Saskatchewan Municipal Board
