The Village of Clavet Office Hours

Monday to Thursday - 9:30am to 4:30pm (Closed Statutory Holidays)

Reminder – Please put **your name, address or account number** on your e-transfers. The name on the e-transfer is ***not*** always the same name on file. It makes it very difficult to make sure the funds go to the right place.

Utility Billing- Reminder that Utility billing is monthly. If you do not have a radio meter and need to submit water meter reading, please submit reading June 25-30. Please continue to send water meter reading in last week of each month.

Recycle/Garbage Bins – **If your bin is full, please do not use your neighbor's bin.** Contact the office for solutions. Please remember to put your bin out the night before collection day to make sure it is collected. Please make sure to remove your bin off the street in a timely matter. Bins should be removed from the street by the following day after collection. If you have multiple bins together, please make sure there is 4 feet in between them to be collected.

Dogs must be leashed while walking them in the Village.

Please keep your pets off others property.



Barking Dogs: Please keep pets inside while you're away or at night to help prevent excessive barking. Thanks for helping maintain a peaceful neighborhood!

Untidy Yards – The office has received concerns about individuals not keeping their yards or back alleys clean and tidy. Please ensure your outdoor areas are well-maintained.

- E-transfer – We have auto deposit so no need for passwords. Please put in the notes of your e-transfer your Civic address, Name and what you are paying taxes, utilities, dog/cat licence etc. Send e-transfer to clavetvillage@sasktel.net

- TD or Credit Union – check with these institutions on their transfer methods.

PUBLIC NOTICE

VILLAGE OF CLAVET

Public notice is hereby given that the Council of the Village of Clavet intends to adopt a bylaw under The Planning and Development Act, 2007 to amend Bylaw #2010-03, known as the Village of Clavet Zoning Bylaw.

INTENT

- 1.1 The proposed Bylaw No. 2025-01 to amend by adding the following definition under the definition for "Minister":

Mixed-Use Development:

PUBLIC INSPECTION

Any person may inspect the proposed Bylaw at the Village of Clavet, 9 Main Street, Clavet, Saskatchewan between the hours of 9:30 a.m. to 4:30 p.m., Monday to Thursday, excluding holidays, up to July 3, 2025.

Council will hold a public hearing on Monday July 3, 2025, at 7:00 p.m. at the Clavet Community Hall located on Second Ave East in Clavet. This hearing provides an opportunity for any person or group that wants to comment on the proposed bylaw(s). Council will also consider written comments received at the hearing or delivered to the undersigned at the municipal office before the hearing.
